DIRECTIONS FOR USE:

Apply only as directed during the growing season. Apply when a regular feeding of nitrogen, phosphate and potash is desired.

APPLICATION RATES:

For all applications: LIGHT: 4.80 lbs./1,000 sq. ft.

NORMAL: 5.95 lbs./1,000 sq. ft.

Apply to dry foliage. Water in after application with a minimum of 0.2 inches of water to help move particles into the turf canopy. Do not collect clippings for at least one mowing following application to avoid particle pick-up. Do not apply to putting greens. Do not apply with a drop-type spreader.

Cool-Season Grasses:

• Apply at the NORMAL RATE.

• Exception: Apply at the LIGHT RATE when temperatures exceed 80°F.

Warm-Season Grasses:

• Apply at the NORMAL RATE during the growing season.

Store in a clean, dry place. Reseal opened bag by folding top down and securing. Use only clean, dry spreaders. Do not leave unused product in spreaders.
